Statement from Detective Macon OCA/19AS18022
On 09/12/2019 at approximately 1509 hours, I was contacted by Sgt. Routh in reference to a suspicious death located at 711 South Church Street Apartment (A). Detective Snodgrass, Detective Fulk and I went to the address and while we were on scene it was advised a search warrant for the residence was needed. Detective Snodgrass typed up a search warrant for the apartment and I executed the warrant.

I began by taking several still photographs of the outside portion of the apartment complex showing 711 South Church Street and the front door of Apartment (A) picture numbers (61-64). I took several still photographs of the door frame to capture that the door and the door frame had not been tampered with picture numbers (65-69). I then took several more still photographs from inside the front door facing towards the inside living room area picture numbers (71-84). I proceeded to the kitchen/dining room area and took several more still photographs, picture numbers (85-103). Once I was finished with the kitchen and dining room area I proceeded towards the Northwest bedroom via a small hallway picture numbers (102-105). Picture number (105-107) is of the spare bathroom nearest to the living and dining rooms. The decedent's bedroom was located on the Northeast side of the apartment and the spare bedroom was on the Northwest side. I took several still photographs of the spare bedroom picture numbers (108-115).

After, I was through with documenting the majority of the residence I proceeded to the decedent's bedroom and bathroom picture numbers (116-157). I then went back over the entire apartment taking several still photographs of items of interest including what appeared to be small suspected blood spots on the south wall of the decedent's bedroom, picture numbers (158-183). I documented the temperature of the apartment along with the a/c setting on the thermostat, Temperature was 74 degrees with the a/c on and set on 60 degrees, picture numbers (184-185).

I responded to 364 White Oak Street, Randolph Health to take several still photographs of the decedent's injuries, while he was still being treated at the Hospital. I documented his face, chest, arm, and side of torso, a portion of his back, legs, feet and toes. I observed several injuries about his person but I did not observe any wounds with deep lacerations at the time of my observation. The decedent did have a small laceration about his face above his left eye brow.

I responded back to the decedent's apartment and Detective Johnson and I began going through the spare bedroom documenting items as we were attempting to organize the room in preparation of us going through the decedent's bedroom, picture numbers (0036-0053).

Detective Johnson, Suddeth and I then went through the decedent's bedroom decluttering the room while looking for evidence and items that had suspected blood spot transfers. We were able to determine that several items had suspected blood on them and suspicious items that could have been used as a weapon were collected as evidence, picture numbers (054-0101). We were able to locate the decedent's wallet with U.S. currency inside the wallet, picture numbers (0117-0121). I documented with still photographs the pillow that the decedent was using while he slept, picture numbers (0122-0123). We were able to locate the decedent's truck keys which were located behind the bathroom door, picture number (0145-0146).

I processed the decedent's truck which was a Gray 2016 Chevrolet Silverado Truck

displaying a North Carolina Registration Number Plate of (FKW-7075), picture numbers (0156-0195). I was able to locate a silver brief case in the rear passenger seat of the truck. I took the silver briefcase back inside the apartment due to neighbors watching and forcibly opened the case. I located one black suppressor inside the brief case along with a victim's rights paper from King County in the State of Washington, picture numbers (0196-0200). The silver brief case picture number is (0176-0177).

While processing the crime scene I observed several pairs of sexual items inside the decedent's apartment which was located on the bedroom floor and inside a white basket located in his closet along with bondage restraints, picture numbers (0064-0073 and 0116.

I did have to take to the Office of the Chief Medical Examiner all the pictures that were taken from the scene to assist them in determining his injuries.

This concludes my involvement in the investigation.
